No payment by May 1 of respective calendar year will result in a lien being placed on the property and legal costs in the amount of \$113 being added to the amount due. No payment by October 1 of respective calendar year results in certification of the delinquent account, including an additional \$120 certification fee, to the Jefferson County Treasurer for collection with ad valorem taxes.

(b) Annual Non-Residential Sewer Services Charge

- (1) Non-residential sewer service charges shall be assessed at \$360 per equivalent residential rate, based upon the domestic water consumption for the previous year, less allowances for proven landscaped areas.
- (2) Non-Residential Delinquency Charges: No payment in full of invoiced amounts within 60 days of due date will result in the imposition of a \$185 delinquency charge and certification to the Jefferson County Treasurer for collection with ad valorem taxes of any outstanding amounts.
